User ID: This is your personal name and address number. Each owner of a property has their own individual User ID number so that they may access any and all properties on which they have title. You can find this number on your property tax or utility bill. This is the Customer # located on your property tax notice or your utility bill (on Tax Notices for the year 2011 and earlier this field is called AR No.).

Account Number: This is the number that appears in the Account # box on your billing. If you are registering using your property tax notice the account number is your Roll#.
