




Tax Reduction Strategy

WHAT'S NEW IN PARKLAND COUNTY

Parkland County wins sustainability award

Parkland County is proud to have won a Sustainable Communities Award for the County's work in determining the value of natural infrastructure in rural road networks. The County is reducing road maintenance

and drainage costs through an informed partnership that considers the needs of nature and the community, and this award celebrates our work as an environmental innovator among Canadian cities and communities of all sizes.

The Federation of Canadian Municipalities' Sustainable Communities Awards recognized our Community Sustainability departments' efforts in the Natural

Asset Management category — a reflection of Parkland County's commitment to sustainable environmental practices. It was the only award given to a community in Western Canada this year.

About the project

In recent years, Parkland County has experienced various extreme weather events, from large-scale wildfires and drought to flooding and water disruptions. These events affect our residents' quality of life, impact service delivery, and increase costs. Maintaining our road and drainage networks is among the largest annual expenses for a rural municipality.

In consideration of these costs, Parkland County investigated how natural assets, such as wetlands, help to reduce the effects of extreme weather events over time — and how we can restore these assets to reduce servicing costs.

Alongside our partners, the Community Sustainability team researched the cost and benefit of preserving and improving wetlands and other natural infrastructure on agricultural land. The goal was to identify cost savings, efficiency, and

other metrics to create easier decision-making for municipal stakeholders and to stress the potential negative impacts if further ecosystem loss was to occur. Overall, the project demonstrated that municipalities can and should consider the value of natural assets in their everyday decision-making. Parkland County now has a stronger understanding of the value of natural assets to our community, especially the road and drainage network. We also have an improved understanding of the financial costs of restoring natural assets.

Council, management, and staff are now better equipped to make decisions regarding natural assets. We are using results and recommendations from this project to better understand the value of natural infrastructure as well as the potential impact of its loss on the community. These outcomes will also help us consider natural assets in the decision-making process and as practical solutions to drainage issues and road washouts.

Parkland County would like to thank our partners at ALUS, The North Saskatchewan Watershed Alliance, InnoTech Alberta, and Dr. Wanhong Yang's team from the University of Guelph for their efforts on this project.

The Trails Strategy Plan

This plan will provide long term direction to trail development and the creation of an integrated trail network for County residents and visitors. The plan will focus on the next 20 years, with a more detailed focus on the next 5 – 10 years.

Bylaw Review

A process that includes input from the community on the updating of seven existing bylaws and the creation of one new bylaw. The resulting input will be drafted into a report and presented to council.

Land Use Bylaw Redesign

Parkland County's Land Use Bylaw regulates how and where land within Parkland County develops. A provincial requirement, Land Use Regulations are reviewed and updated regularly to reflect the needs of the community. As part of a regular and ongoing process, Parkland County is updating the County's Land Use Bylaw in an effort to streamline regulations and create clear and transparent decision-making processes for development in the county. The County's Land Use Bylaw was last updated in 2017, with a previous update in 2009 and minor changes completed every few years. Now that the former Village of Wabamun is part of the County, it is desirable to ensure consistency throughout the County and integrate Wabamun into the Land Use Bylaw. This project is a county-led initiative with a project team of County staff, and changes to Parkland County's Land Use Bylaw will be informed by feedback from local residents and business owners with regular engagement planned throughout the project. Ultimately, the updated Land Use Bylaw will go before Council for final approval where residents and business owners will also have an opportunity to share their feedback with Council.

We want to hear your thoughts on how to ensure our Land Use Bylaw is responsive to the unique needs of Parkland County residents and businesses. 


Weed Control Program

Not all plants are good! There are specific weeds you cannot leave unmanaged on your property. These weeds, designated as "prohibited noxious and noxious" under the Alberta Weed Control Act, can spread rapidly and cause serious problems. Property owners are responsible for controlling these plants on their property.

As shown in the image below, we have selected areas of the County where we will focus our resources for 2023 weed inspections and control. We will begin with controlling weeds on County lands and then begin assessing private properties. Properties with noxious and prohibited noxious weeds will be inspected and recommendations for control will be given.

Please note: A weed notice can be issued in extreme cases where no efforts are made to prevent the spread of noxious weeds or destroy prohibited noxious weeds.



Vegetation Control Program

Parkland County's Agricultural Services Department will be using a combination of methods to control noxious and prohibited noxious weeds on County lands as designated under the Alberta Weed Control Act. These methods include:

- · Herbicide application
- Mowing
- · Biological control agents
- · Manual removal

Herbicides used this upcoming season may include: Clearview PCP #29752 Truvist PCP# 30920

Lontrel XC PCP #32795 Milestone PCP #28517 Navius PCP #30922 Escort PCP #23005


Biological control agents are used to control Yellow Toadflax, Leafy Spurge and Canada Thistle at sensitive sites throughout the County.

For your safety and worker safety, please refrain from approaching staff or disturbing biological control sites while work is in progress.

Congratulations to Parkland County Fire Chief Brian Cornforth on this accomplishment, and thank you to the rest of the fire services team for all you do to protect our community.




Amazon Opening in Acheson

Parkland County is excited for the opening of the new Amazon Robotic fulfillment centre in the Acheson Industrial Area.

This will be Amazon's first robotic fulfillment centre in Alberta. boasting five stories and around 2.9 million square feet – the size of more than 50 NFL football fields. The centre will be used to pick, pack and ship a variety of items to Amazon customers. Robots help the flow of inventory by delivering mobile shelving units to stations, increasing the number of products that can be packed per hour.

"We are thrilled for the upcoming opening of the new Amazon robotic fulfillment centre here in our Acheson Industrial Area," said Mayor Allan Gamble. "This facility will boost our economy by creating over 1,000 jobs. It also demonstrates why Parkland County is a great place to do business."

Amazon joins many other local, Canadian and international businesses who have chosen to call Acheson home including Champion Pet Foods, Overwaitea Food Group, and Fountain Tire. "It's great to see our vision for Parkland County's economic future become reality with the opening of this fulfillment centre in Acheson," said Laura Swain, Chief Administrative Officer. Bringing in Broadband

High speed internet is a necessary utility, and improving and expanding this service throughout Parkland County will keep residents and businesses connected and ready for whatever the future will bring. As part of the County's broadband strategy to bring reliable and affordable high-speed internet to our residents, we will be swiftly

WHAT IS BROADBAND?

Broadband refers to a type of highspeed internet connection that can be accomplished in various ways, such as through coaxial cables, fibre-optic cables, and radio waves. The faster and more reliable option is fibre optics, which is what we are working on bringing to more homes in the County.

moving forward with a partner on the next stage of this project. In this early phase of our broadband rollout, we expect network construction and installation to be completed in 2023, which will allow fibre-based home internet connections to at least 3,000 households in the initial target area — northeast and northcentral Parkland County.

DID YOU KNOW?

Parkland County is responsible for 1,250 km of graveled roads and 800 km of asphalt surface roads.

COUNTY ROAD CLEARING

Wondering how roads are prioritized for snow clearing? We aim to have the main road system (arterial and collector roads) plowed within 36 hours after a snow fall stops, and other local, subdivision and hamlet roads plowed within 72 hours. The type, depth, duration, and intensity of the snowfall may impact the overall timelines as the County addresses roads in priority sequence. Drivers should always allow extra time as conditions may vary.

SNOW REMOVAL PRIORITY:

- 1. Arterial Roadways (highly used roads)
- 2. Collector roads (roadways connecting arterial and subdivision roads)
- 3. Local and Subdivision roads (including Hamlets)
- 4. Parking lots (Parkland County facilities and Community Halls)

During snow removal, ridges or windrows may occur across approaches. Residents are responsible for maintaining their approaches.

Provincial Highways

The province is responsible for clearing all provincial highways. Parkland County takes care of range roads, township roads, and subdivision roads. Please contact Alberta Transportation with concerns on Provincial Highways or view **511.alberta.ca** for updated highway conditions.

Snow Removal Subsidy Program

We know that shoveling can be a lot of work, and we recognize that not every resident has the ability to do so. Our Snow Removal Subsidy Program provides funding support to physically challenged residents for snow removal. Up to \$300 per winter season is available per household.

CRITERIA:

- Person applying must be the owner or renter of the residence where the driveway is being plowed, and it must be their primary residence.
- Residence must be located within Parkland County.
- Person must be physically challenged either by age or disability and must provide a doctor's certificate or note verifying that they are physically unable to remove snow from their driveway.
- All persons 18 years of age or older living in the residence must be physically disabled.

Residents can apply by completing the Snow Removal Subsidy Program application, and submit along with the required doctor's certificate or note, to:

Applications are reviewed and residents will be contacted. If approved, the resident will be responsible for making arrangements to have their driveway cleared. Residents then submit proof of work completed, via paid invoice, to the County for reimbursement. Proof of payment must be submitted before April 30, 2023. Spring Thaw

Soon enough, spring will be in the air! When temperatures rise and daily highs are above freezing, spring thaw begins. Here are some tips to help you out:

- Inspect your property for drainage issues.
- Ensure culverts are clear to avoid potential flooding.
- Stay off the ice and stay safe!
- Make sure eaves and downspouts are extended away from your home.
- Double check that sump pump!

Road Bans

Road bans in Parkland County are usually placed on the roadways any time after mid-March and stay in effect until the end of May. Road bans are dependent on weather; therefore, this time period can fluctuate. Most oil surfaced and asphalt base roads are banned at 75%, but there are some roads that are banned at 50%. The potential for damage and the current condition of the road dictates the percentage of ban. Gravel roads are not generally banned but can be if conditions warrant. 
