BYLAW 2021-18

**BEING A BYLAW FOR THE PURPOSE OF REPEALING CERTAIN FORMER VILLAGE OF WABAMUN
BYLAWS OR RESOLUTIONS**

WHEREAS the Municipal Government Act, RSA 2000, c.M-26 authorizes council to pass bylaws for municipal purposes;

WHEREAS in accordance with Order in Council 386/2020 effective January 1, 2021 the Village of Wabamun was dissolved and the former area of the village designated as a hamlet in Parkland County;

WHEREAS under the provisions of Order in Council 386/2020 bylaws and resolutions of the former area of the village continue to apply until the bylaws or resolutions are repealed, amended or replaced by the Council of Parkland County;

WHEREAS there are a number of former village bylaws or resolutions that can be repealed as the subject matter is addressed by a Parkland County bylaw or the former village bylaws or resolutions are not necessary in Parkland County;

NOW THEREFORE the Council of Parkland County, duly assembled and under the authority of the Municipal Government Act, as amended, hereby enacts the following:

1. The following former Village of Wabamun bylaws are hereby repealed:
